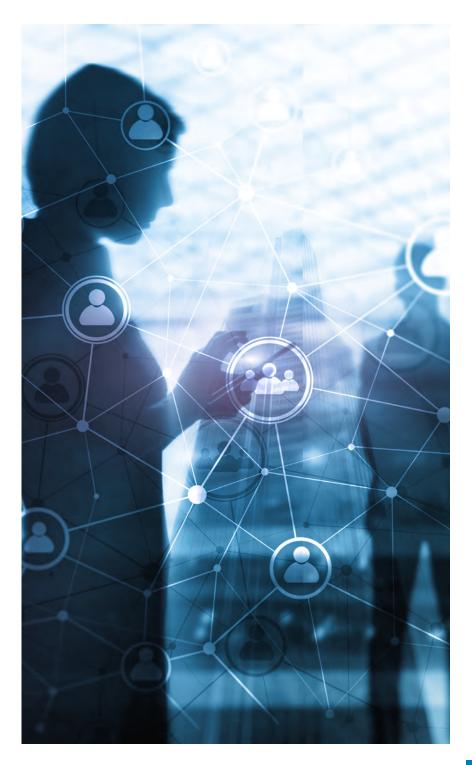


### About

The payment process was also inefficient and time-consuming.



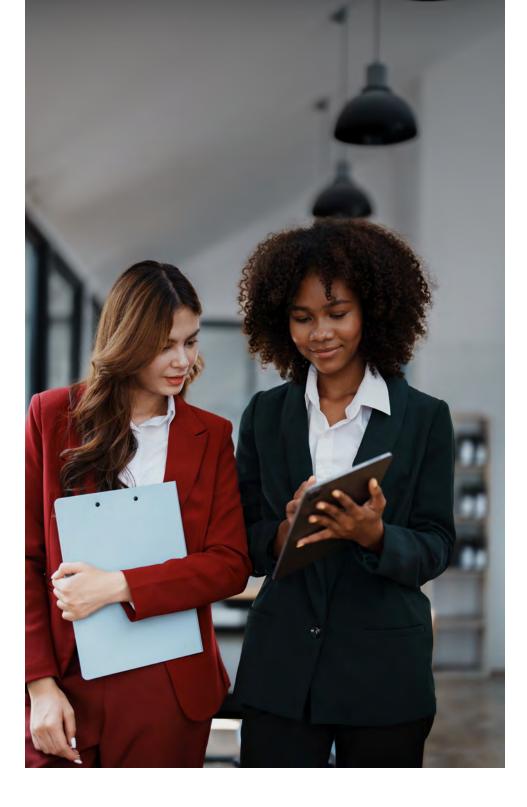
### Gaining Financial Control
